Seasonal Summer Landfill Pass Annual Application

Terms and Conditions:

- ✓ Application must be completed and postmarked by January 31st each year requesting a pass.
- ✓ Once approved, passes will be mailed to the permanent address listed on application prior to April 1st with a receipt.
- ✓ Applications are subject to receipt of a posted payment, complete application, signed application, and approval. Notification will be made and payment will be returned if application is not approved.
- ✓ Once issued, any passes revoked by either the applicant or Town of Stubbs will not receive a full or partial refund.
- ✓ Waste is limited to household garbage, not to include waste of other individuals or other materials such as constructions materials.
- ✓ The Town of Stubbs trash site/Rusk County recycling center is open every Saturday 8am-1pm. There is a limit at this site of trash equal to two 30-gallon trash bags. The recycling center, located at same site, does not limit intake of recyclables. Exceeding the trash limit may result in refusal of services. The Town of Stubbs and its employees maintain the right to refuse services.
- ✓ Provide a photo ID upon request with pass for employees of Town of Stubbs for pass verification.
- ✓ This pass is for only the applicant(s) who are also the owner(S) of the property in the Town of Stubbs.
- ✓ The purpose of this pass is to allow seasonal residents that maintain a part-time residence in the Town of Stubbs. Part-time is defined by the Town of Stubbs as less than six months, more than four months with an established residence that maintains utilities.
- ✓ Replacement passes must be requested to the Town of Stubbs with payment of \$5.00
- ✓ Failure to comply with terms and conditions may result in revocation of pass.
